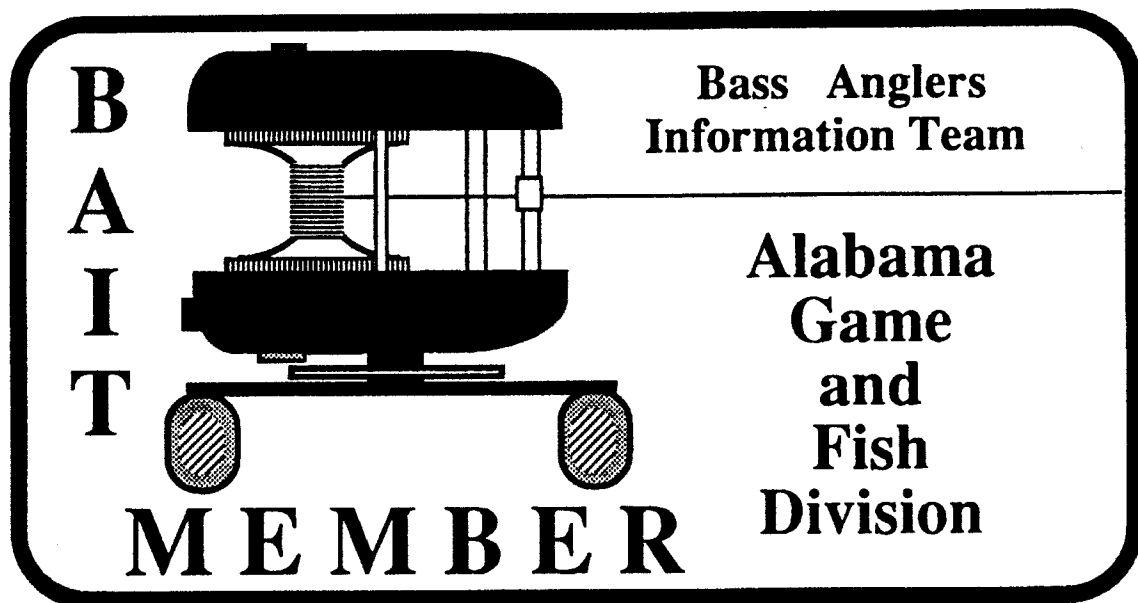

INTRODUCTION

The B.A.I.T. program completed nine years of bass tournament summarization in 1994. The objective of the program has always been to gather information on bass populations by combining the efforts of bass club members and state fisheries biologists. The B.A.I.T. program summarizes catch data already being collected by participating clubs on reservoir bass populations. These results are used by State fisheries biologists in combination with data from other sources as a basis for fisheries management decisions. Bass anglers use the report to establish future tournament sites or to locate a reservoir that provides a particular type of fishing action.

Through 1994, 3,638 tournament reports were summarized. More than 150 clubs participated through the first nine years of the program. B.A.I.T. team anglers have spent 926,533 hours collecting data for this program. They have contributed data from 227,262 bass that weighed 375,392 pounds.

METHODS

Every year an effort has been made to maintain the support of the previous year's clubs and to enlist the support of new clubs through news releases and letters. Participating club officers or tournament directors are sent the previous year's annual report, with tournament report postcards to be completed following each tournament. Clubs are assigned individual numbers to insure confidentiality. As tournament cards are received, they are checked for accuracy and entered into a computer database. Club officers are contacted when data are suspected to be erroneous. Compilation and analysis of the data are performed following receipt of December tournament reports. Statewide information is sorted by reservoir, and by club.

To rank reservoirs, five "fishing quality" indicators were used: percent of successful anglers (percent of anglers with one or more bass at weigh-in), bass average weight, number of bass per angler-day, pounds of bass per angler-day, and hours required to catch a bass five pounds or larger. Since the length of a fishing day varies between tournaments, an angler-day is defined as 10 hours of fishing effort. A minimum of five tournaments for an individual reservoir is considered necessary for minimum confidence in each reservoir dataset. Reservoirs with five or more tournament reports are ranked for each of the quality indicators. Values are assigned to each rank and an overall rank is determined for each reservoir by summing the values of the five quality indicators. This ranking system is intended to be a quick reference for club tournament site selection. It is not a "best and worst" list of Alabama reservoirs and should not be interpreted that way.

RESULTS AND DISCUSSION

Bass clubs submitted 664 tournament reports during 1994, topping last year's success by a whopping 106 reports. Club representatives did an excellent job filling out the cards and few reports were rejected due to incomplete or erroneous information. Seventy three clubs or tournament organizations provided data in 1994. Two hundred

and seven tournament reports from Alabama waters were received from Dr. Carl Quertermus of West Georgia College, who summarizes tournament data from the Georgia B.A.S.S. Federation. Without his support and the support of the Georgia Federation, several northeast Alabama reservoirs would not have been well represented in the quality indicator rankings (Table 2). Once again we must stress that reports from more locations increase the capability of the summaries to reflect actual fish population conditions and not just a good or poor day's fishing by one or two clubs.

In 1994, tournament reports were received for 32 bodies of water that were fished 153,992 hours. B.A.I.T. anglers caught 36,098 bass (12 inches and larger) that weighed 62,294 pounds (Table 1). A total of 589 bass five pounds and larger were reported for an overall catch rate of one 5 pound bass or larger for every 261 hours of fishing (roughly the same as last year, 272 hours). The number of bass over 8.0 pounds in Table 5 was similar to last year (18 in 1993 and 17 in 1994). The Georgia B.A.S.S. Federation caught 3 of the 17 bass over 8.0 pounds while fishing Weiss, West Point, and Eufaula. Nine of the 17 bass were caught between February 20 and April 2. When catching big bass is a priority, lakes that consistently produce big bass should be fished during the pre-spawn period for greatest success.

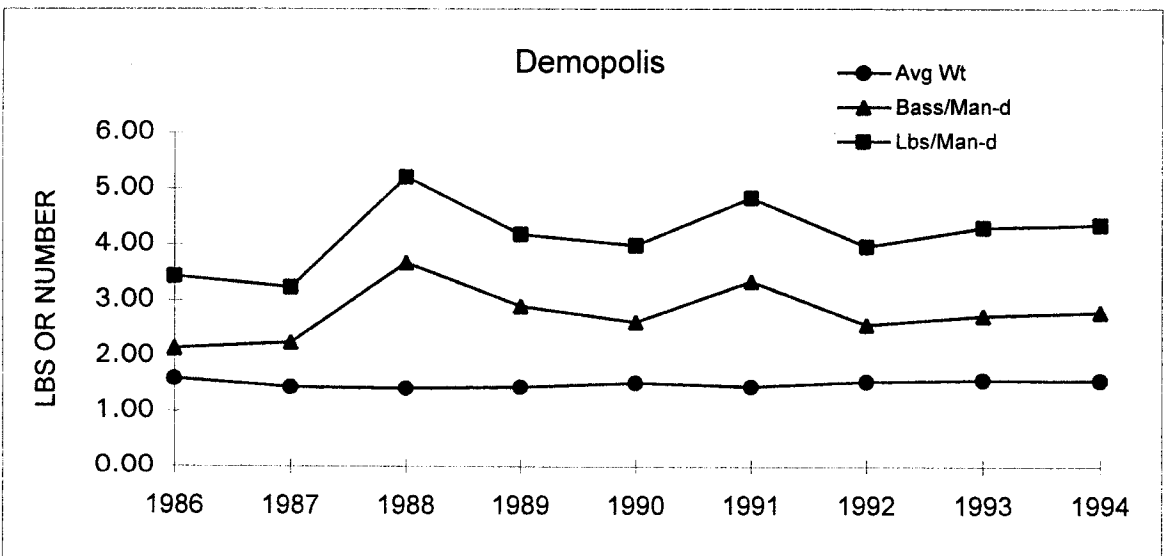
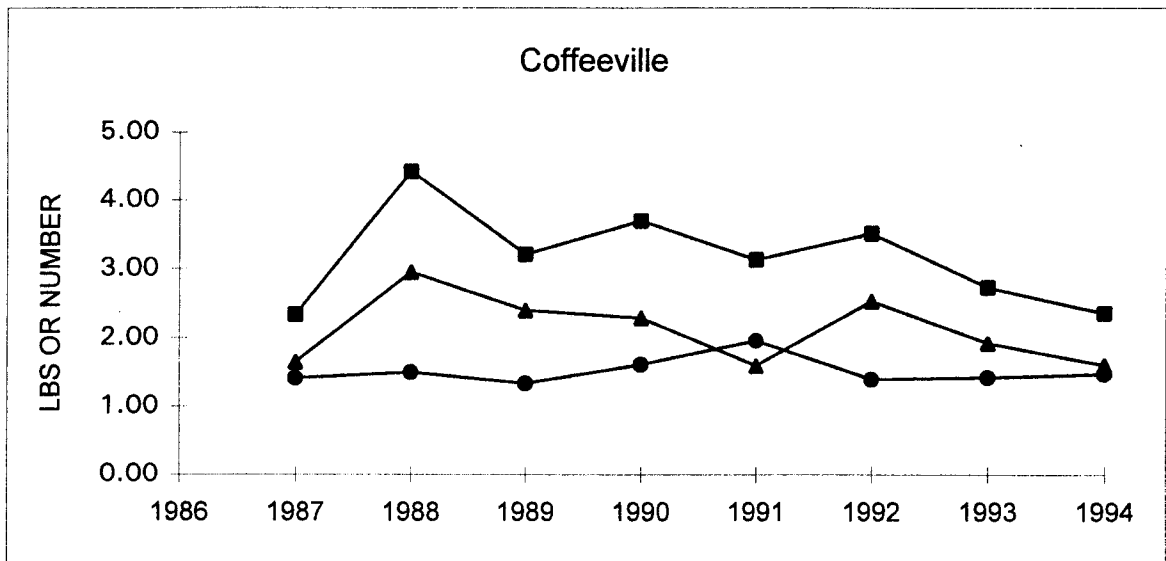
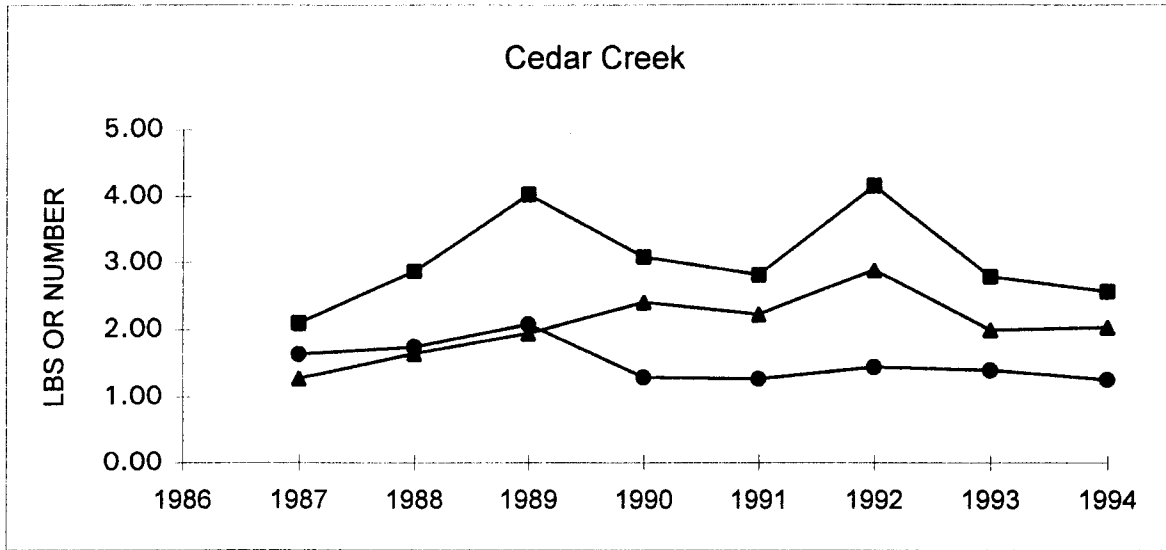
Figure 1. Annual catch for B.A.I.T. tournaments

Statewide catch rates in 1994 for number and pounds of fish increased slightly from 1993 (Figure 1). This can be explained in part by the improved fishing success recorded at six bodies of water while only two sites reported declines. Guntersville and Harris also reported declines but these were directly related to the recent imposition of length limits, a 15-inch minimum and a 13- to 16-inch slot, respectively.

Of the seventy three clubs or tournament organizations that submitted data during 1994, 43 submitted five or more tournament reports, similar to last year at 41. Twenty-three clubs submitted 10 or more reports, down slightly from last year's 26 (Table 3). Every year, lack of full reporting by some clubs remains a limiting factor in this program. Twenty contributors submitted only one report. All club representatives should understand that every tournament report is important if this program continues to be successful. A list of clubs contributing tournament results for the 1994 B.A.I.T. report is presented in Table 4.

More tournament reports were received from West Point (76) than any other location. Logan Martin (60) and Eufaula (54) were a distant second and third. Guntersville, Jordan, Lay, Martin, Millers Ferry, Mitchell, Neely Henry, Weiss, Wheeler, and the Mobile Delta each had 20 or more tournament reports (Table 1). Distribution of tournament reports across reservoirs improved from last year. A good distribution of reports provides more representative catch statistics from which meaningful summaries can be prepared.

Of the 32 reservoirs from which reports were received, 27 had five or more tournament reports. The following comments deal with these 27 reservoirs (Table 2). The percent of successful anglers (those with one or more fish) ranged from 37 at Guntersville to 87 at Harris. The average weight of bass caught ranged from 1.26 at

Cedar Creek to 3.13 at Eufaula (16-inch size limit, Table 1). The statewide average weight was 1.73 pounds; approximately the same since 1989. Catch rates ranged from 0.86 at West Point to 3.45 at Martin. Catch rate expressed as pounds per angler-day ranged from 1.95 at West Point to 5.69 at Jordan.

Overall, Jordan was judged the top-ranked reservoir in Alabama, replacing Wheeler from last year. An unusual occurrence happened this year with a two way tie for both second and third place. Gainesville on the Tombigbee River and Logan Martin on the Coosa River tied for second place. Jones Bluff on the Alabama River and Wheeler on the Tennessee River tied for third. However, the primary intent of Table 2 is not to determine the overall "best" reservoir, but to characterize the fishery of each reservoir. As an example, look at the rankings for Martin. It produces high numbers of fish but of relatively low average weight. This results in a moderate ranking for pounds per angler-day, the measure most important at a weigh-in. Is this good fishing? It depends on who you ask. If you want big fish, Martin is probably not the place to go, but if you want to catch good numbers of fish, it's one of the best.

As more bass populations are managed with length limits in our State and the effects of these restrictions on harvest are expressed in the results of the B.A.I.T. report, we need to define the effects of these limits on the fisheries and the B.A.I.T. results. Length limits are imposed to increase the number of fish below a minimum length or within a specified slot. Because all minimum lengths and slots will be above the 12-inch limit fished in most tournaments, they will reduce the total harvest in numbers and pounds. However, those fish weighed in will be larger (longer) by virtue of the minimum length or slot limit. In the B.A.I.T. report, length limit lakes will always rank high for average weight and near the bottom for percent success, bass per angler-day, and pounds per angler-day. For instance, bass per angler-day averages 2.34 statewide but is roughly half of that at West Point, Guntersville and Eufaula. Average weight, statewide in 1994 was 1.73 pounds but at West Point, Wilson, Guntersville and Eufaula average weight was well over 2 pounds. The average weight of bass 12 inches and longer has not increased in these populations. The average weights are higher only because the fish weighed in are longer.

Length limits remained in effect during the year on Eufaula and West Point (16-inch minimum), Wilson and Guntersville (15-inch minimum), Pickwick (14-inch minimum on smallmouth), and Harris (13- to 16-inch slot). Catch rates at Harris and Guntersville responded as was expected by declining the first year following imposition (Appendix A). However, the response at Wilson was unusual. Bass per angler-day declined as expected, but pounds per angler-day actually increased to the highest level ever recorded. This is an example of the effect of a dominant year class in the fishery. Older larger fish, usually spawned in a single year, are sufficiently abundant to maintain, or in this case increase, the pounds of fish at weigh-in but the overall catch of fish is reduced as a result of the 15-inch length limit

Graphs in Appendix A provide you with a historical record of how your favorite waters have performed in the B.A.I.T. program since 1986. A few words of caution,

these graphs are not restricted to bodies of water with five or more tournaments. Data points for some years may be represented by only one tournament or completely absent in some cases. However, those situations are restricted to those waters that generally have not been included in the quality indicator rankings. Secondly, when comparing water bodies, be aware that the scale on the vertical axes have maximum ranges that vary. You can use these graphs to predict 1995 fishing by looking for trends. For instance, Aliceville, Eufaula, Logan Martin, Pickwick, Tuscaloosa, and the Mobile Delta showed improvements in fishing quality indicators in 1994. Noticeable declines in fishing quality were seen at Bankhead and West Point. As mentioned previously, the declines seen at Guntersville and Harris are directly attributable to the imposition of length limits and do not reflect actual declines in fishing quality.

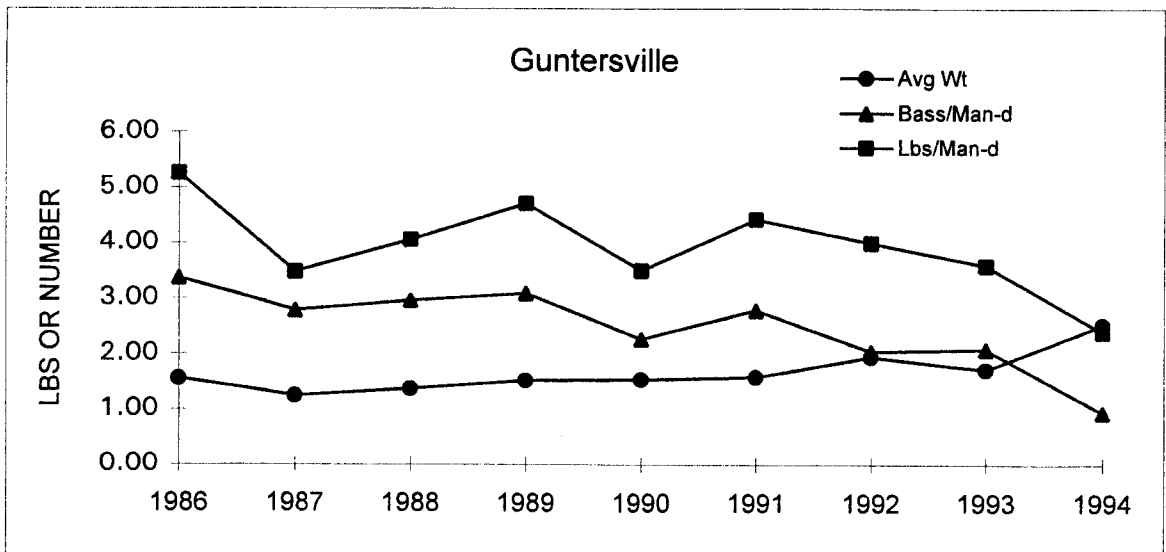
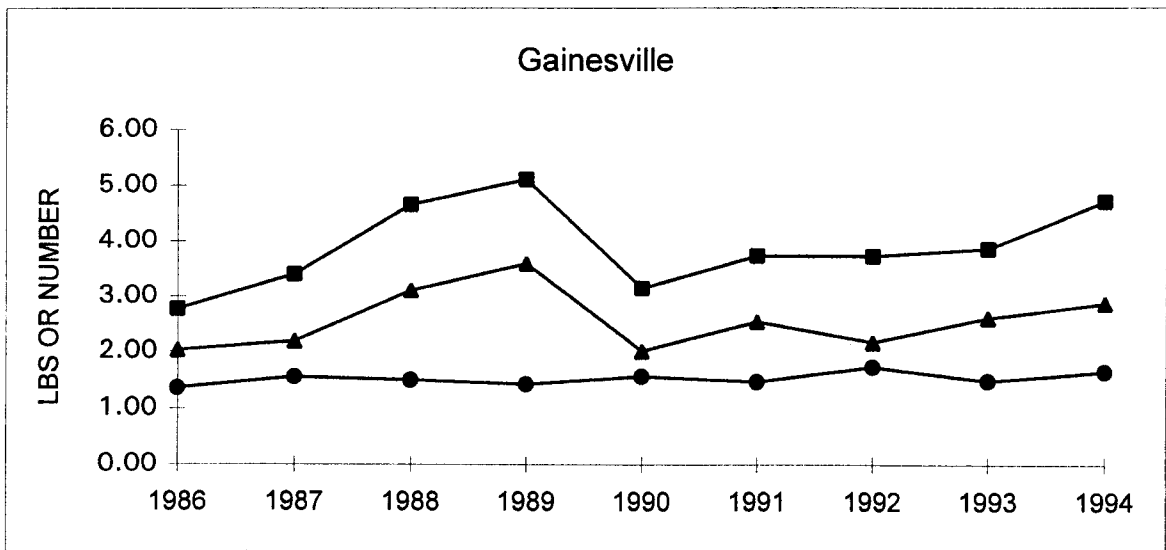
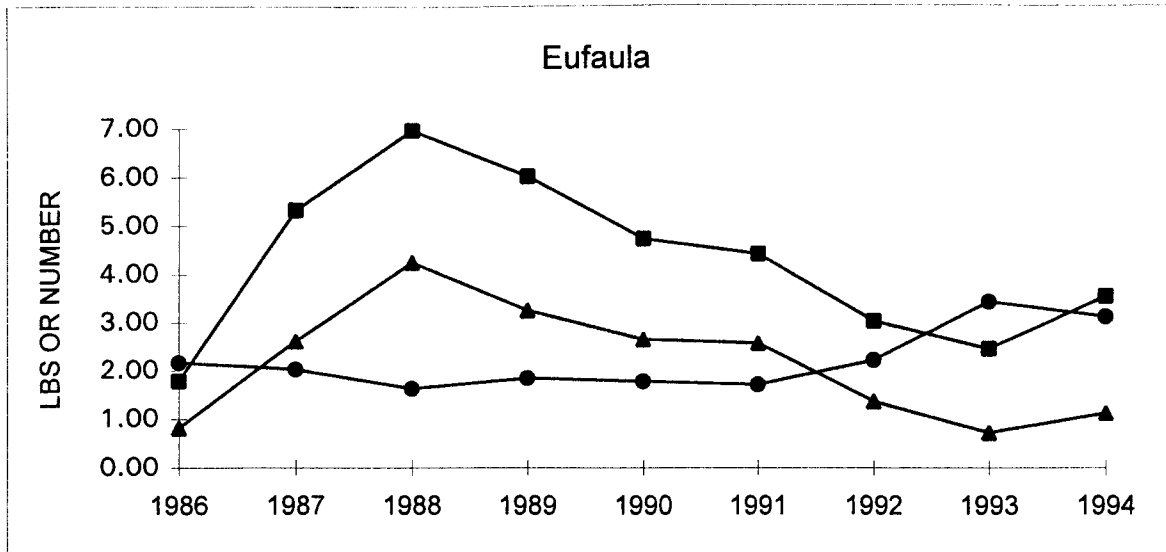
